Approval of the Minutes of Board of Studies, Academic Council and report of Finance committee meetings (for the academic year 2023-24)

She also presented the results of B.Ed. & M.Ed. of 2022-24 academic batch for the approval.

The meeting unanimously resolved to record the results of the semester examinations of B.Ed. and M.Ed. degree programme.

Action Plan for the Academic Year 2023-2024

Dr. D.S. Prasobh Madhavan ,IQAC Co-ordinator presented the Plan of Action for the academic year 2023-2024 .The plan was approved unanimously.

Suggestions/ Recommendations of the members on Academic Enrichment

The members of the Governing Body appreciated the proposed reforms and modifications to be incorporated in the curriculum regulations of B.Ed. and M.Ed. programme.

The Regional Joint Director of Collegiate Education, Dr.R. Bhaskaran (State Government Nominee asked for few clarifications regarding the financial and budget review. He suggested to utilize a considerable amount for the capacity building programmes for the teachers and periodic NET coaching for the students.

The management nominee and the subject expert Dr. M.A. Sudheer ,Professor of Emiratus, The Gandhigram Rural university, Dindigal congratulated the management, the principal and the staff for promptly implementing most of the things suggested in the previous Governing body meeting and gave his insights to consider while revamping the curriculum in the next academic year.

- ▲ To take more initiatives to strengthen Faculty Development Programmes.
- ▲ Looking in to the possibility of collaborative research and student exchange programme by signing MOU's with foreign universities.
- ▲ Teacher Educators should take up new research projects and he mentioned a list of funding agencies
- ▲ Experiential learning projects should be encouraged more for M.Ed students.
- ▲ Orientation should be given to Teacher Educators about the latest evaluation procedures.
- ▲ Women's cell operating in the college should cater to many teacher education programmes. They should organize child development and parental involvement programmes.
- ▲ Mathematics Olympiads should be initiated by Mathematics Club.
- ▲ Educational tours should also include visiting few prominent educational institutions or places of educational importance.
- ▲ The institution should promote more Arts and sports activities to imbibe the NEP 2020 integration of arts and sports in Education
- ▲ He made an appeal to the institution to apply for projects related to the orientation and sensitization on NEP 2020 with Madanmohan Malaviya Teacher Training Centre (MMTC).
- ▲ The institution should have access to Traditional Knowledge system and

- should be transacted through the curriculum.
- ▲ The details of the course work for research scholars should be stated in a more transparent way.
- ▲ The curriculum load for both B.Ed. and M.Ed. should be reduced and subjects related to Special education can be added.
- Dr.R.Mukundan (Academic Advisor) stated the need of strengthening the counseling centre with an intention to help the student community as well as the needy people. He also pointed out that the counseling centre may be of much help to the schools in the neighborhood in addressing the issues of children. Training should also be given to all teachers in counseling.
- Dr.B.C.Sobha (Academic Advisor) urged for the utmost need of curriculum revision and syllabus modification in concordance with the regulations of NEP2020.
- In any other matters with the permission of the chair Prof. K.Rajeswari, Prof and Head, Centre for Research and Development elaborated the activities carried out by the research centre.
- Dr,K,Gireesh Kumar, Assisstant Professor in History proposed the formal vote of thanks .The meeting came to an end by 1.45 P.M.
