**MEMORANDUM OF UNDERSTANDING**

This agreement is made on this day 5<sup>th</sup> May 2023 between N.V.K.S.D. College of Education, Attoor, Attoor P.O, Kanniyakumari District, Tamil Nadu – 629177 and Civil- Consumer Protection And Civic Rights Association (Reg.No. 55/2010) Kulasekharam, Kanniyakumari District.

In the spirit of mutual interest in co-operation, NVKSD and Civil- Consumer Protection And Civic Rights Association Kulasekharam, Kanniyakumari District, Tamil Nadu enter into this Memorandum of Understanding (MoU) to promote joint Educational Collaboration to create Public awareness and agree as follows.

## SCOPE OF COLLABORATION

2. Extension and outreach activities
3. Conducting Consumer awareness Road Safety Programmes
4. Joint technical sessions, seminars and conferences.

*All activities shall be subjected to the approval by each institutions.*

## FINANCIAL COMMITMENT:

Expenses incurred shall be borne by the concerned institutions.

## INTELLECTUAL PROPERTY RIGHTS:

All IPR values will be equally shared by both the institutions among investigators.

## DURATION AND EVALUATION

This MoU shall be in effect for a period of five (5) years from the date of Signature. Either party may request termination of this agreement, in writing Ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing, ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.

Both the parties acknowledge that information (if any) occurred regarding faculty/students may be protected and agree not to make it available to any third party.

This agreement may subsequently be modified only by a written document executed by both parties.
