MEMORANDUM OF UNDERSTANDING

This agreement is made on this day 2nd March 2022 between N.V.K.S.D College of Education, Attoor, AttoorP.O, Kanniyakumari District, Tamilnadu – 629177 and HEAL Movement, Nagercoil, Kanniyakumari District, Tamilnadu.

In the spirit of mutual interest in co-operation, NVKSD College of Education and HEAL Movement, Nagercoil, Kanniyakumari District, Tamilnadu enter into this Memorandum of Understanding (MoU) to develop environmental awareness, and carry out research studies on various social issues to the younger generation.

N.V.K.S.D. College of Education, was established in the year 1963, as a pioneer teacher education institution in Kanniyakumari District. It is affiliated to Tamil Nadu Teachers Education University and recognized by NCTE, U.G.C and re-accredited by NAAC with A grade with CGPA 3.32 and granted with Autonomous status by UGC. M.Ed. degree course was started in the year 1987 and was elevated to the status of Research Centre in Education in 2013 by Tamil Nadu Teachers Education University, Chennai.

In 1984, a group of 15 socially concerned young men and women, involved in a development discourse and contextual analysis of socio, economic and cultural situation, consequently decided to 'act' to create a platform for social change of the most marginalized and disadvantaged communities in Kanniyakumari District. They have decided to concentrate on access to basic amenities, entitlements and claiming social security from the Governments both State and Union. The group had been operational solely on voluntary basis. The aim and objectives of HEAL is to mobilize, organize and empower marginalized communities in a collective platform and ensure sustainability.

SCOPE OF COLLABORATION

1. Undertake projects on Social issues
2. Connecting education with sustainable life practices
3. Organising scientific, literary and social activities


All activities shall be subjected to the approval by each institution.


Both the parties acknowledge that information (if any) occurred regarding faculty/students may be protected and agrees not to make it available to any third party.
